COOKIES POLICY

1. Introduction

WRDNB (hereinafter, the “Company”, “we”, “us” or “our”) is a Cyprus Investment Firm (CIF) authorised and regulated by the Cyprus Securities and Exchange Commission (CySEC) with CIF Licence number 424/23.

At **WRDNB Ltd** we are committed to protecting the privacy and security of your personal data in accordance with applicable European Union and Republic of Cyprus legislation.

This Cookie Policy (hereinafter, the “**Policy**”) describes how we use cookies and other similar technologies (collectively referred to as “**Cookies**”) to collect, process, and store your personal information, and explains the purposes for using these technologies, and the rights you have over your personal data.

This Policy applies to your use of our Website, trading platform, mobile applications, or other online services offered by the Company in accordance with the Client Agreement (collectively, the “Website”).

This Policy is issued in accordance with:

- Regulation (EU) 2016/679 (General Data Protection Regulation – “GDPR”);
- The Protection of Natural Persons with regard to the Processing of Personal Data and for the Free Movement of Such Data Law 125(I)/2018 of the Republic of Cyprus;
- The Electronic Communications and Postal Services Law 112(I)/2004 (as amended), implementing Directive 2002/58/EC (ePrivacy Directive);
- and any relevant guidance issued by the Office of the Commissioner for Personal Data Protection of the Republic of Cyprus.

By accessing or using our Website, you acknowledge that you have read and understood the terms of this Policy.

2. How We Use Cookies

Our website and app use cookies and other similar technologies (collectively referred to as “**Cookies**”) to collect data from your device. Cookies are often used to improve your user experience, enable functionalities on the website and the app, facilitate security, and provide the business with marketing information about the website and app visitors.

We rely on your consent to use cookies, except for those that are essential for the smooth operation of the website or the app. You can reject cookies at any time by adjusting your browser or app settings; however, this may impact your ability to fully explore and use the features of our website or app.

3. Types of Cookies We Use

(a) **Necessary Cookies**: These are used to ensure the smooth operation of our website or app and provide core functionalities. Due to their necessity, these cookies cannot be turned off in your system;

(b) **Statistics Cookies:** These are used to analyze traffic and improve navigation and performance of our website or app. They help us understand which pages are most and least popular and how visitors navigate the site. All information collected by these cookies is aggregated and processed anonymously;

(c) **Preferences Cookies:** These allow us to provide enhanced functionality and personalization by remembering your preferences and choices made in the past.

(d) **Marketing Cookies:** These are used to collect information about the user's behavior and preferences to deliver ads that are more relevant to your interests. They are usually employed by third-party advertising networks.

4. **Managing Cookies and Withdrawing Consent**

You can access our Cookie consent tool via the “**Cookies Settings**” link in the footer of our website or manage the use of cookies through your browser settings. You can reject or withdraw your consent for certain cookies at any time, but please note that some cookies (such as necessary cookies) cannot be turned off.

5. **Third-Party Cookies**

We may collaborate with third-party advertising networks, analytics service providers, and others, allowing them to place cookies on our website or app. These third parties may collect information based on their respective cookie policies and use it for personalized advertising or analytics services. For more information about these third-party cookies, please refer to their privacy policies.

6. **Cookie Storage and Data Transfer**

The cookie data we collect may be stored outside of the European Economic Area (EEA). We will take appropriate measures to ensure that your data is protected during such transfers, including through standard contractual clauses or other legal mechanisms.

We regularly review and update this Cookie Policy, so it may change at any time. In the event of significant changes, the updated version will be posted on our website. We encourage you to review this Policy periodically to remain informed about how we use Cookies.
